1. Entitlement to Attend and Vote

The Company specifies that only those holders of ordinary shares of 5p each in the capital of the Company registered in the Company's Register of Members at:

- 1.1. Close of business on Wednesday 27 May 2020; or
- 1.2. if this meeting is adjourned, at close of business two working days prior to the adjourned meeting;

shall be entitled vote at the meeting in respect of the number of ordinary shares of 5p each in the capital of the Company registered in their name at that time. Subsequent changes to entries in the Register of Members as at close of business on Wednesday 27 May 2020 shall be disregarded in determining the rights of any person to attend or vote at the meeting.

2. Appointment of Proxies

2.1. If you are a member of the Company at the time set out in paragraphs 1.1 or 1.2 above, you are entitled to appoint a proxy to exercise all or any of your rights on a poll vote at the Meeting and you should have received a proxy form

with this notice of meeting. You can only appoint a proxy using the procedures set out in these notes and the notes to your proxy form.

- 2.2. In light of the evolving Covid-19 circumstances, unfortunately shareholders will not be able to attend the AGM in person but are encouraged to submit their votes by proxy and appoint the Chair of the Meeting as their proxy.
- 2.3. You may complete more than one form of proxy provided each form of proxy is appointed to exercise rights attached to different shares. You may not complete more than one form of proxy to exercise rights attached to any one share. To complete more than one form of proxy you must complete a separate Form of Proxy. Members can copy their original Form of Proxy, or additional Forms of Proxy can be obtained from Link Asset Services, PXS, The Registry, 34 Beckenham Road, Beckenham, Kent, BR3 4TU.
- 2.4. To direct your proxy how to vote on the resolutions mark the appropriate box on your proxy form with an 'X'. To abstain from voting on a resolution, select the relevant "Vote withheld" box. A vote withheld is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against the resolution. If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the meeting.
- 2.5. To appoint a valid proxy using the proxy form, the form must be:
 - 2.5.1. completed and signed;
 - 2.5.2. sent or delivered to Link Asset Services, PXS, The Registry, 34 Beckenham Road, Beckenham, Kent, BR3 4TU; and
 - 2.5.3. received by Link Asset Services no later than 48 hours before the meeting.
- 2.6. In the case of joint holders, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding (the first-named being the most senior).
- 2.7. Any power of attorney or any other authority under which your proxy form is signed (or a duly certified copy of such power or authority) must be included with your proxy form.
- 2.8. If you submit more than one valid proxy appointment, the appointment received last before the latest time for the receipt of proxies will take precedence.
- 2.9. You may not use any electronic address provided in your proxy form to communicate with the Company for any purposes other than those expressly stated.

Explanatory Notes to the Resolutions to be put to Shareholders at the Annual General Meeting

Resolution 1 – Audited Accounts

The Directors of the Company are required under the Companies Act 2006 to lay the audited accounts and reports before the Company in General Meeting.

Resolution 2 – Re-election of Daryn Robinson as a director

In accordance with the Company's Articles of Association, Daryn Robinson is required to retire as a Director. Resolution 3 – Reappointment and Remuneration of Auditors
